



Pennsylvania District 22 Policy Statement

Subject; **LIABILITY & ACCIDENT INSURANCE FOR PA DISTRICT 22 STAFF PERSONS**

Effective Date – **-11/12/2010**

Little League Baseball/Softball (as understood at this moment) cover all PA District 22 Staff persons (Game Officials and Volunteer Umpires) for Liability & Accident Insurance provided the following conditions are met;

1. The person must be an unpaid volunteer.
2. The person must have completed and passed a background check for the current year.
3. The person will only be insured if they are scheduled in writing to attend or work the event in which any adverse event occurs (going to, during or immediately following).
4. Under no circumstances can alcoholic beverages play a part in any PA District 22 event.

Be advised that this being the case only those individuals on the PA District 22 Staff that are scheduled to **ATTEND** or **WORK** various PA District 22 events are the only individuals allowed to participate in the event with the assurance that Little League's Liability and Accident Insurance is in force thru PA District 22.

PA District 22 events are (but not limited to) the following;

- Presidents Advisory Board Meetings
- Staff Advisory Meetings
- Game Official Meetings
- Volunteer Umpires Meetings
- Special Meetings
- Section 8 Meetings
- PA State Meetings
- East Region & Williamsport Clinics
- Credentials Committee Meeting and Events
- Managers Meetings
- PA District 22 Tournament Games
- Section 8 and PA State games hosted by PA District 22

FAQ

Q – Are regular season games or inter-league play games considered PA District 22 events?

A – No, since PA District 22 does not schedule or oversee these games.

Q – As a game official who is not assigned to a game that I attend, and I'm asked to assist by the assigned game official can I assist.

A – Yes, if first the assigned game official contacts the District Administrator and/or the Tournament Administrator and they concur, at which point that person will be added to the assigned schedule.

Q- As a person on the PA District 22 Staff am I insured for regular season and interleague play games or events?

A – Yes, but only through the Local Little League provided;

You have passed a current year Background Check **thru the local Little League as well as the District.**

You are a member of the League and are listed on their records as such.

Under no circumstances can alcoholic beverages play a part in event.

The interleague play games have been approved by the District

Administrator via a completed and signed "Request for Inter-League Play" form.

Q- Is the Background Check completed by PA District 22 valid for Local Little League purposes?

A – **No**, Once completed you will receive an ID card which will be dated and signed by the District Administrator **which will be valid only for your involvement in PA District 22 events.**

Q- Can PA District 22 host a picnic / hospitality suite / dinner / party / fund raiser, etc. where the district provides (purchases and furnishes) alcoholic beverages?

A – No, unless the district wants to accept the risks of uncovered liabilities.

Q – As a member of the PA District 22 Staff, if my local Little League runs my background check, is this acceptable for PA District 22's purposes?

A- Yes, provided the local Little League President confirms your compliance via a signed and dated letter to the District Administrator.
